## NCVF Uniform Requirements and Reminders

This document provides a brief overview of uniform requirements and reminders for NCVF competition.

NCVF will adhere to USAV uniform rules.
All NCVF exceptions are listed on NCVF Page 1 and NCVF Page 2.
USAV has not posted their 2022-23 Uniform Requirements.
NCVF will use the 2021-22 Uniform Requirements until further notice!

## Contrast, Match Referees, and Head Referees

Since contrast can be subjective (eye of the beholder, lighting, wetness) some jersey combinations like (black/gray) may be IN THE MARGIN.
The legality of combinations which are IN THE MARGIN is left to the officials conducting the match.
Some match officials may permit the combination while others may prohibit it.
Match officials have the right to prohibit the team from playing in such combinations.
If a team chooses such a combination, it is recommended that an additional jersey, which will provide a CLEARLY CONTRASTING combination, be available.

A Head Official should rarely overturn the decision of the match officials.

## NEWLY PURCHASED UNIFORMS

Any newly purchased uniforms must meet the current uniform rules as established by USA Volleyball.
These rules can be found on the USA Volleyball Officiating website.

## EXISTING UNIFORMS

## VARSITY UNIFORMS Donated to NCVF Teams

Any varsity uniform which is given to an NCVF club team is considered legal.
The varsity uniform must have been legal for competition within the last 5 years. If requested by the NCVF Rules Committee, proof of authenticity must be provided.

## Legal Uniforms Now Made Illegal by Rule Changes Team Must Request A Waiver For These Uniforms.

To reduce financial burden on teams, there will be a two (2) year (seasons) grace period for any uniform rendered illegal by an immediate rule change.

If any rule has been posted with an effective date two (2) or more years after its announcement, that rule will be enforced starting on its effective date.

## WAIVERS - Waivers Should Be The Exception, Not The Norm!!!

On a case by case basis, teams may request a uniform waiver giving them permission to play in an illegal uniform. The NCVF Playing Rules Committee and Conference Commissioners will review each case and may grant a waiver, permitting the team to play in an illegal (by rule) uniform.

Some reasons for such a waiver to be granted include but are not limited to:

1. Manufacturer no longer producing identical uniform model, or fonts.

Team must every effort to match, as closely as possible, color, trim, font style, and font size to the existing uniforms.
2. Actual mockup did not match an NCVF approved mockup.

Proof of approval may be required.
3. Other extenuating circumstances

## Timespan of Waiver

Waivers will be granted for up to two (2) years depending on the case.

## Proof of Waiver

Teams will be given an electronic (PDF) waiver document from the NCVF Playing Rules Committee.
Teams must present the waiver to any match officials requesting proof of waiver.

## Extension of Waivers

Extension of waivers beyond the timespan above or a change in uniforms will only be granted in the most extreme circumstances.

## Additional Waivers

The team's next set of uniforms must be legal as defined by all current effective rules.
No further waivers will be granted for new uniforms to any team that has already received a waiver for uniforms.

## Before Purchasing Uniforms

Teams are strongly encouraged to review this document and the USA Volleyball Rules Book prior to purchasing uniforms. If you have questions about the legality of uniforms, please contact your Region Office or Region Officials/Referee Chair. If your team(s) will be attending any National events (bid tournaments, national qualifiers, etc.), USAV has developed a new website to allow teams to submit jerseys for approval (https://usavolleyball.org/resources-for-clubs/) Scroll down to Uniform Approval. The USAV Rules Interpreter will review your jersey designs and provide an approval form indicating what jerseys may be worn in combination with each other. If any jerseys are illegal, this information will also be provided.

## KEY POINTS REGARDING LEGALITY

1. Jerseys must be identical for all regular players (non-Libero).
2. *NEW* - Uniform Bottoms may differ in style and cut but must all be the same color. (excluding the Libero)
3. Uniforms must be numbered in a permanent manner using Arabic numerals.
a. Numbers 1-99 are legal. Numbers 0, 00-09 are not legal and will not be permitted
b. Number minimum height: Front 4"; Back 6". Recommended: Front 6"; Back 8".
c. The stripe forming the number must be solid with a minimum width of $3 / 4$ ".
d. The stripe forming the number must clearly contrast with the jersey. See Diagram A
4. Uniform numbers must be clearly visible, entire number must clearly contrast with the jersey, and be centered on the players chest and upper back. Chest is from the neck to the sternum, not the stomach. See Number Placement Guide in this document. The main goal is to see the number at a glance. Placement and size are factors.
5. Numbers on shorts/pants (if any) must match jersey number. Uniform bottoms may differ for regular players with a few exceptions. See Diagram B
6. USAV 19.2 changed in March 2016. It now reads: The Libero(s) must wear a jersey that clearly contrasts with the jersey of their teammates.

Certain combinations of colors do not meet any standard of contrast. Some are, but not limited to, black/navy; red/maroon/burgundy; black/dark green; white/light yellow; navy/maroon. Such combinations must be avoided. One way to get a better idea of contrast is to take a photo of both jerseys and convert it to monochrome (gray scale). If it is difficult to determine which is which, this combination should be avoided.

Since contrast can be subjective (eye of the beholder, lighting, wetness) some jersey combinations like (black/gray) may be IN THE MARGIN. If a team chooses such a combination, it is recommended that an additional jersey, which will provide a CLEARLY CONTRASTING combination, be available.

The legality of combinations which are IN THE MARGIN is determined by the policies of the event. Each Region develops its own policies for Regional events. At National events, the head referee and tournament director will assist in resolving any issues.

## LOGOS / TEAM NAMES PLAYER NAMES Placement



Logos may be placed anywhere on the jerseys providing:

1. The number is placed legally.
2. The visibility/readability of the number is not hindered.
3. The contrast of the jersey is not affected.

With respect to the other jersey (libero or regular jersey)

In this example, the only one of these numbers that is legal is the upper right number. It is a white number on a black background. That would make the number contrast to the jersey color. The number may have a border, but the border does not have to contrast.

The other numbers are either black on black or dark gray on black which are not contrasting.




Manufacturers logos may be different as long as the shorts are the same color and the logo is not larger than $21 / 4$ ".


Players may have a number on their shorts as long as it matches their jersey number. Not all players have to have a number on their shorts.


A player may play with a club/sponsor logo on their shorts even if the rest of the team does not have that logo. If more than one player has a club/sponsor logo on their shorts, they must be the same logo in the same position. Not all players have to have the logo.

## CONTINUING for 2021-2022 Season

Uniform bottoms may differ provided all bottoms are the same color. (excluding the libero). No waiver is needed if a player chooses to wear a different style of bottoms. Types of bottoms include spandex (of any length), gym style shorts (of any length), pants of any length, or culottes. All other rules regarding manufacturer logos, numbers, and logos from above still apply.

All of these styles together would be legal
